Call to Order: President Stehle called the meeting to order at 9:05 am.

Consideration of Minutes: The Board considered minutes from their May 12th in person meeting and their June 14th virtual meeting. A motion was made and passed unanimously to approve the minutes.

Financials: Ms. Mellen reviewed the unaudited FY2022 financials, and they were accepted unanimously.

Discussion of the VML Annual Conference: There was general discussion around the annual conference, the need for additional training throughout the year and how to determine the location of the annual conference. A subcommittee consisting of Ms. Cristol, Mr. Wood and Mr. Rush was formed and a motion was made to engage the Spark Mill to assist with this subcommittee. The motion passed unanimously.

A second motion was made to confirm the location of the 2023 conference in Norfolk and it passed unanimously.

Discussion of 13 E. Franklin: There was discussion about the building owned by VML at 13 E. Franklin and the repairs needed and taking place. A motion passed unanimously to explore options on the building and other office space with a broker. This discussion also confirmed a prior vote by the Board in which the Executive Director was authorized to sell the building.

Adjournment. The meeting was adjourned at 10:44 am.
