Consideration of Minutes: The Board considered minutes from their March virtual meeting. A motion was made and passed unanimously to approve the minutes.

2024 VML Budget: Ms. Mellen reviewed the proposed operating budget. A motion was made passed unanimously to approve the budget.

Building Offer: Mr. Wiley presented an overview of the unsolicited proposal to purchase the VML building. A motion was made to direct the Executive Director to obtain an appraisal of the building and report back market conditions in Richmond. The motion passed unanimously.

Discussion of the VML Annual Conference: There was discussion about the 2024 annual conference and the proposals by both Alexandria and Virginia Beach. A motion was made to accept the proposal from Virginia Beach and the motion passed with some opposition.

Next Meeting: A motion was made to cancel the August meeting due to scheduling conflicts. The motion was passed unanimously.

Presentations: The Spark Mill led the board through Strategic Planning and Jim Stuart gave a presentation of GovDeals who is a Community Business Member of VML.

Adjournment. The meeting was adjourned at 12:20 pm.

The board self-assessment survey was distributed via email to all 12 members of the Virginia Municipal League Board, after a few emails bounced it was sent out by VML via link to the board. Between the initial email and the follow-up link, 9 of the 12 board members responded.

In this report you will find a summary of the data received from the survey, organized by focus area in alignment with the survey. The final section includes the general feedback and comments made by board members in the open-ended sections of the survey.

Overall, your results were very positive. Even your lower scoring sections (board preparedness for meetings and utilization of board member skills and experience) still had 78% of members answer affirmingly. The survey would indicate you have an active and engaged board that understands and does what is expected of them and works well together and with the staff. If this does not accurately reflect the reality of the board, the opportunity may live in clarifying roles and expectations.
